Dear Parents/Carers,

This is the first safeguarding letter for parents/carers of this academic year. I hope you find it useful to have some key information highlighted to you with regards to safeguarding. This letter will follow the same format as in previous years; focusing on two key topics and signposting you to additional documents and websites specific to these topics.

As a school we have a duty to safeguard students in our care and we take this responsibility seriously ensuring we are compliant with statutory guidance. We have a child protection policy in place that is reviewed annually and strict safeguarding procedures that staff must adhere to at all times. Staff receive regular training and updates around specific safeguarding issues throughout the year. When necessary we may need to report our concerns to MASH (Multi-Agency Safeguarding Hub) via their front door service, as part of these procedures to ensure our students are safe.

Early Help

Early help is a supportive service that can be offered by any professional that works with children and families that need some additional support. These can be initiated by professionals or can be requested via parent/carers to be initiated. Early help is an approach that brings services and professionals together to improve outcomes for families. Families do not have to have safeguarding concerns to have early help plans open, these can be for a range of reasons including SEND, attendance and referrals onto level 2/3 services that the early help team provides. As part of the early help process, consent will be gathered to store information and Team Around the Family (TAF) meetings will be established to look at support and identify strengths the families have. Substance and Alcohol Misuse

We also need to be mindful that when we are looking at substance and alcohol misuse we also need to be aware that this can also apply to some children and young people who may misuse these due to a range of contextual issues.
